



Breaking Down Debriefing

Step Up Together Improvement Cycle





What is Debriefing and Why Do it?

- Hear and integrate different perspectives
- Reinforce good practices
- Translate learning into change/improvement
- Build teamwork
- Quality Improvement:
 - Identify a process or system that needs attention
 - Assign team member or group to create solution and choose a QI process
 - Close the loop, train for new processes, and follow-up

DEBRIEFING AND ACTION PLANNING GUIDE

Review the checklist of observed behaviors as a team and discuss subjective assessments such as communication style with team members and family, role clarity, and effectiveness at clinical tasks.

Reflection Questions

- What happened here? Ask 1-2 people to give a brief high-level summary so everyone's on the same page.
- What went well? Give everyone a chance to share the good stuff they noticed before critiquing.
- What needs attention or improvement? Try to focus on processes and systems, not assigning blame.
- Are there other appropriate ways to manage this emergency or transport? Consider different approaches such as who might accompany the patient, dyad vs. separate transfers, etc.
- Were we prepared for this emergency? The answer will help clarify the Action Steps.

Action Steps

- What changes are needed to processes or procedures? Make sure to assign someone to follow-up on the change.
- How should this emergency be documented in the medical record? Discuss any documentation standards and tools such as order sets or dot-phrases available to clinicians.
- What other reporting is required for this emergency transfer? This could include accreditation or licensing bodies, malpractice carriers, and internal organizational reporting.
- What other follow up would be expected after this emergency? Consider follow-up for patient/family or staff, or other next steps.

Let's Debrief:

Debriefing Questions

What happened?

Give just a brief, high-level summary so everyone's on the same page.

What went well?

Give everyone a chance to share the good stuff they noticed before critiquing.

What needs attention or improvement?

Try to focus on processes and systems, not assigning blame.

What should we do differently going forward?

Make sure to assign someone to follow through on the change.

Preparing for Full Transfer Drill

Reminder of why we are doing this...

Preparing for Full Transfer Drill

	Type of Drill	Who's Involved	Planning Needs
<u></u>	Mini Drill	Solo, two-person team, any small group	Can be impromptu, e.g. conducted on shift with available staff, during orientation, or as a "station" in a skills practice day.
	Team Drill	Full team from practice/facility	Schedule in advance at regular times, compensate time to participate.
	Full Transfer Drill	Full team plus transport and/or hospital personnel	Requires coordination and advanced planning with community midwifery, EMS, and hospital teams.

Common questions/concerns

Potential timeline / Steps

- Select Drill Implementation Toolkit
- Identify stakeholders and agree on running full transfer drill
- Schedule date (likely 3-4hrs for full process) and notify/block time for all participants/necessary staff
- Gather supplies, block calendars/schedules
- Drill coordinator(s) to review toolkit in depth and identify drill roles
- Day-of preparation and introduction of team to case and roles; ensure all necessary parties are aware of drill

Day-of expectations

- Run scenario once.
- Maintain high fidelity which can be a little uncomfortable and anxiety-producing
- ~3-4hrs from set-up to debrief
- Consider ways to compensate staff for their time
- Complete Drill Reporting Form!
